Information about pupils at The Collett School, St Luke's School and Forest House Education Centre

Data Protection Act 1998: How we use pupil information

We collect and hold personal information relating to our pupils and may also receive information about them from their previous school, local authority and/or the Department for Education (DfE). We use this personal data to:

•	support our pupils' learning
	monitor and report on their progress
	provide appropriate pastoral care; and
	assess the quality of our services

This information will include their contact details, national curriculum assessment results, attendance information, any exclusion information, where they go after they leave us and personal characteristics such as their ethnic group, any special educational needs they may have as well as relevant medical information. For pupils enrolling for post 14 qualifications, the Learning Records Service will give us the unique learner number (ULN) and may also give us details about your learning or qualifications.

Once our pupils reach the age of 13, the law requires us to pass on certain information to Hertfordshire Local Authority who have responsibilities in relation to the education or training of 13-19 year olds. We may also share certain personal data relating to children aged 16 and over with post-16 education and training providers in order to secure appropriate services for them. A parent/guardian can request that **only** their child's name, address and date of birth be passed to Hertfordshire Local Authority by informing the Data Controller, *Mr Stephen Hoult-Allen, Headteacher.*

This right is transferred to the child once he/she reaches the age 16. For more information about services for young people, please go to our local authority website; www.herts.org.uk. We will not give information about our pupils to anyone without your consent unless the law and our policies allow us to do so. If you want to receive a copy of the information about your son/daughter that we hold, please contact the Data Controller, Mr Stephen Hoult-Allen, Headteacher.

We are required, by law, to pass certain information about our pupils to our local authority (LA) and the Department for Education (DfE). DfE may also share pupil level personal data that we supply to them, with third parties. This will only take place where legislation allows it to do so and it is in compliance with the Data Protection Act 1998.

Decisions on whether DfE releases this personal data to third parties are subject to a robust approval process and are based on a detailed assessment of who is requesting the data, the purpose for which it is required, the level and sensitivity of data requested and the arrangements in place to store and handle the data. To be granted access to pupil level data, requestors must comply with strict terms and conditions covering the confidentiality and handling of data, security arrangements and retention and use of the data.

Information about the school workforce: those employed to teach, or otherwise engaged to work with The Collett School, St Luke's School and Forest House Education Centre

We process personal data relating to those we employ to work at, or otherwise engage to work at, our school. This is for employment purposes to assist in the running of the school

 and/or to enable individuals to be paid. The collection of this information will benefit both national and local users by: improving the management of workforce data across the sector enabling development of a comprehensive picture of the workforce and how it is deployed informing the development of recruitment and retention policies allowing better financial modelling and planning enabling ethnicity and disability monitoring; and supporting the work of the School Teachers' Review Body 	
This personal data includes identifiers such as names and National Insurance numbers and characteristics such as ethnic group, employment contracts and remuneration details, qualifications and absence information.	
We will not share information about you with third parties without your consent unless the law allows us to. We are required, by law, to pass on some of this personal data to: our local authority the Department for Education (DfE)	
Information about children in need or children looked after	
We collect and process information about children in our care and children to whom we provide services. We use this personal data to:	
□ provide them with pastoral care; and	
□ assess the quality of our services	
We will not give information about children in our care to anyone without relevant consent unless the law and our policies allow us to do so.	
We are required, by law, to pass on some of this information to the Department for Education (DfE) which uses it to; develop national policies, manage local authority performance, administer and allocate funding and identify and encourage good practice. DfE may share child level personal data that we supply to them, with third parties. This will only take place where legislation allows it to do so and it is in compliance with the Data Protection Act 1998.	
Decisions on whether DfE releases this personal data to third parties are subject to a robust approval process and are based on a detailed assessment of who is requesting the data, the purpose for which it is required, the level and sensitivity of data requested and the arrangements in place to store and handle the data. To be granted access to pupil level data, requestors must comply with strict terms and conditions covering the confidentiality and handling of data, security arrangements and retention and use of the data.
